Program Overview

Leadership Lenawee is the region's premier leadership development program. The program runs from September – May each year, meeting the first and third Wednesday of each month, from 8:30a – 12:00p. Participants are engaged in a variety of topics and activities and are exposed to the business community throughout Lenawee County.

Program Requirements

Applicants should be aware of the requirements for participation and completion of the Leadership Lenawee program. As space in the program is limited, it is imperative that members of the cohort be committed to the program as active participants. Requirements include:

1. Employer/supervisor support for the participant's involvement in the program. This includes allowing the participant to attend each Leadership Lenawee session (1st and 3rd Wednesdays of each month, from 8:30a – 12:00p).
2. A minimum of 80% attendance at sessions is required for completion of the program.
3. Certain requirements, including but not limited to attendance at local government meetings and service club meetings, the selection of a mentor for the duration of the program, and involvement in a local nonprofit service project, are highly encouraged aspects of participation in the Leadership Lenawee program.
4. Program fee of \$1,000 (\$1,250 for non-GLCC members) is required for participation.

Applicants should consider the above requirements prior to applying, ensuring that all requirements are able to be met.
